5th April 2015 Hereford Rural South Briefing 21st March - 4th April 2015 Crime Trends

Broad Oak A red Honda TRX400 quad bike was stolen from an outbuilding of an isolated property overnight on Wednesday 25th/Thursday 26th March.

The bike had been well secured within an open brick shed; a vehicle and trailer had been parked across the entrance but the offenders still managed to get the bike out Incident ref 135-s-260315 Garway A Stihl chainsaw was stolen from an insecure shed sometime since it was last used at the end of January Incident ref 376-s-300315

Kingstone Damage was caused to the Kes Childcare garden area between Friday 27th / Monday 30th March; pots, garden items and toys were knocked over and the gazebo was damaged Incident ref 75-s-300315

Over the same weekend and presumably by the same persons; damage was caused to guttering and plant pots at Kingstone & Thruxton primary school Incident ref 354-s-310315

A parcel containing clothing that had been left for collection outside a property in Coldstone Cross was stolen between 3pm on Tuesday 31st March and 3.30pm on Wednesday 1st April. The blue plastic package had been left on top of a shed as arranged with the courier, and securely weighed down Incident ref 535-s-010415

Suspicious vehicles

A white Peugeot partner van NU64CVX was seen in suspicious circumstances in Pontrilas village at 11.30 am on Thursday 2nd April Incident ref 179-s-020415 Scams

This e-mail scam has been around for some time, with a few details altered each time. The e-mail appears to come from someone in your address book - their e-mail account has been hacked and one of these scam e-mails is sent to everyone in that person's address book. Unfortunately, people do sometimes fall for it but most people recognise it as a scam - just delete it. Most of these come from abroad and are impossible to trace.

I'm writing this with tears in my eyes, my family and I came down here to Kiev, Ukraine for a short vacation, unfortunately we were mugged at the park of the hotel where we stayed all cash, credit card and mobile phone were stolen from us but luckily we still have our passports with us.

We've been to the Embassy but the Police are not helping matters at all, the bad news is our flight will be leaving in less than 8-hrs from now but we're having problems settling the hotel bills and the hotel manager won't let us leave until we settle the bills.

I'll need your help (LOAN) financially of £2,000. I promise to make the refund once we get back home. Please let me know if i can count on you and i need you to keep checking your email because it's the only way i can reach you. Regards,

Another 'reader' contacted us regarding another fairly common scam - don't let these callers fool you into thinking you have a problem with your computer.

"yesterday I received two 'phone-calls purporting to come from Microsoft warning me of hackers trying to get into my computer and who had got my password and that was the reason for my "recent problems". Like everyone I have had a few problems. I wouldn't believe him and he got quite aggressive and shouted that he was now going to block my computer. I said "Do that, and then phone me tomorrow when I have more time".

He didn't block my computer....

Then at lunchtime same day I had another call from "Microsoft" – a woman this time, again with an Asian voice, who spoke so quickly I couldn't follow her and I ended the conversation" Results

A white Renault panel van was seized for no tax on the A49 at Much Birch on Thursday 26th March as part of Operation Protect.

A 21 year old male from St Weonards was arrested in Hereford at 3.15am on Sunday 29th March for being drunk and disorderly. He received a caution.

A 23 year old male from Kingstone was arrested in Hereford for assault at 1am on Sunday 5th April.

Good News - £250,000+ of church ornaments recovered PC Wendy Powell, working with the Hereford Proactive team, executed a warrant in Brecon on 28th January 2015 after months of lengthy enquiries. Two males have been arrested and bailed, and many stolen items have been recovered. The items relate to thefts from churches since 2011 from Grosmont, Foy, Much Dewchurch, Dore Abbey, and other local churches as well as churches from as far afield as Oxford and Devon.

It became clear that these items were stolen to order, and the total value of all goods due to their history will be well above that quoted above. The items include statues, carvings, glass, and a very ancient Bible. Enquiries are ongoing to trace the owners of all the items which are currently safely stored in our property store. A fantastic result and a great way for Wendy to finish her career with West Mercia Police - Well Done!

Finally - just a reminder that my email address is not monitored on a twenty four hour a day basis. It could be that I am on rest days, annual leave, training days or simply out of the station attending incidents. For this reason, it is important that incidents are reported to Police on the 101 telephone number rather than by e-mail, so the call taker can make the decision on whether to deploy an Officer or whether to create an incident log etc. It also enables us to deal with any situation that arises in a timely manner. Clehonger A quantity of cut turf and topsoil were stolen from the playing fields where the new play equipment is being built, this happened sometime overnight on Tuesday 28th/Wednesday 29th April

Eaton Bishop A metal cash box containing between £5 - £10 was stolen from a table inside the church over the past few days.

Ewyas Harold A company van parked up in the Westwood Industrial Estate was broken into sometime over the Easter bank Holiday weekend although the theft wasn't discovered until a few days later.

Madley An Ifor Williams 8' x 5' twin axle trailer was stolen from the yard of a farm on the Canon Bridge Road at 10.20pm on Sunday 19th April; the owner saw lights near the farm gate and went to investigate. He saw his trailer disappearing down the road being towed by what he thought was an estate car with a possible part registration VX05 Incident ref 711-s-190415 Suspicious vehicles

A dark blue double cab pick up with something 'rental' written along the side was seen on farmland in Rowlestone on Tuesday 21st April. There were 2 men in the vehicle dressed in army camouflage gear. It appears that the vehicle may have driven over the ground of three neighbouring holdings, as there was evidence of wheel marks. The registration number wasn't seen

A white transit van FN07 FBA was seen in Long Lane, Dorstone/Urishay at 6.15am on Tuesday 21st April, there were three males in the vehicle who looked out of place, especially at that time of the morning.

Scams

Below is another example of an e-mail sent to all contacts in a person's address book purporting to come from the person whose account has been hacked. In this case, the receiver of the e-mail did not recognise the name of the person supposedly sending the cry for help and immediately recognised it as a scam...

I hope all is well with you.

I am afraid I have a problem. J**** and I made a trip to Ankara, Turkey, unfortunately we were mugged at the park of the hotel we are staying, all cash, bank card and mobile phone stolen off us but luckily we still have our passports with us, J**** was devastated at this incident and was rushed to the hospital.

I have been to the embassy and the police here but their response was too casual, I have also made contact with my bank but it would take me 3-5 working days to access funds in my account, the bad news is our flight will be leaving very soon but I am having problems settling the hotel bills and the hotel manager won't let me leave until I settle the bills. I thought I would contact you directly, I need your help/LOAN financially, you are my last resort and hope, all I need right now is £2100, I'll appreciate what you can give if not all and I promise to make the refund once I get back home.

Please let me know if I can count on you and I need you to keep checking your email because it's the only way I can reach you. Best regards

As always, the advice is to delete such e-mails, never reply to them.

Alert from Action Fraud – Online Auction websites

Online auction websites are being used by fraudsters to advertise agricultural machinery for sale which do not exist.

The fraudster advertises on an auction website and gets their victim to agree to purchase farming machinery, making sure that all correspondence is done via email.

The victim then receive emails which claim to be from genuine payment merchants or auction websites which state that the money they have paid for the machinery will be held in an 'escrow account'.

The email indicates the money will be released to the seller, once the person has confirmed that they're happy with the purchase. The email says that this will provide the person with 'buyer protection'. In reality these emails are fraudulent, they don't come from the named companies and the bank accounts are controlled by fraudsters.

Protect yourself:

Always stay within the terms and conditions of the auction websites.

Remember that PayPal do not include vehicles under their buyer protection.

Meet the seller 'face to face' and view the vehicle before parting with any money.

Be vigilant of emails that purport to be from genuine companies and check the 'domain' name of the email address for any inconsistencies.

Check feedback online by searching the associated phone numbers or email addresses of the seller.

If the vehicle is below market value consider whether this is an opportunity which is too good to be true!
