A new Village Hall Constitution had been produced by Sylvia Rothwell They are going to check with The Charities Commission as to protocol when producing a new Constitution

6.3 <u>Management Plan</u> - Management Committee Roles/Duties - Parish Council Roles/Duties A guide for information had been produced by the Parish Clerk and given to all present suggesting that the Village Hall Management Committee should conduct the day to day running of the Village Hall and the Parish Council should look after the fabric and upkeep of the building

6.4 Defibrillator Training and Equipment Monitoring

A well attended, free of charge, training evening on Thursday 31st August 2017 by Mr Nick O'Sullivan took place which has increased awareness of the defibrillator and has given confidence to those who attended on how to use it. It is an excellent machine and an asset to the Village Hall.

The Clerk was instructed to apply for a grant to obtain a defibrillator at Bacton Village Hall

The Clerk had contacted Plusnet reference the telephone line and broadband at Abbeydore Village Hall and had managed to reduce the payments by ± 5.00 per month for the next two years

"Re Planning Application 172150 Upper House Farm HR2 0AU

The Parish Council discussed this application at their September 2017 meeting.

Clearly Herefordshire Council will have to consider the merits of this application in accordance with their policies.

The Parish Council concluded that their approval at this time would be contrary to Policies G7b and G8a & G8b (see below)

POLICY G7 - RURAL ENVIRONMENT AND TRANQUILITY

To protect the integrity of the rural environment and the tranquillity of the Golden Valley development proposals will be supported when they do not give rise to adverse impacts. The following criteria will be used to assess proposals:

b. For business and tourism proposals a Noise Impact Assessment will be required with any planning application, and may be required, in certain circumstances, for other forms of development;

POLICY G8 – DARK SKIES

Obtrusive lighting installations can have a devastating impact in a community, causing nuisance to neighbours, and obscuring views of the night sky, as well as wasting energy. Well-designed lighting installations reduce the risk of crime, and improve public safety. To minimise light pollution in the Golden Valley and to improve the views of our night time skies, planning proposals that include external lighting and significant openings that would allow internal lighting to be seen externally, will have to demonstrate the following:

a) They have undertaken an appropriate assessment and can demonstrate the need for the lighting proposed;

proposed;

b) That care has been taken to provide appropriate lighting, using systems designed to prevent obtrusive lighting nuisance, minimise light pollution and reduce energy consumption.

As the Neighbourhood Development Plan has concluded the Regulation 16 Consultation Stage and is about to enter the examination phase we understand that there is a precedent for an NDP having attained this stage to carry considerable weight for a planning application.

Once these and any issues raised by members of the public are satisfactorily redressed the Parish Council would be happy to consider the application again."

Belmont Between 5pm on Friday 21st and 9am on Tuesday 25th July, a blue Raleigh M-Trax bike was stolen from a bike rack at a community building in Ruckhall Lane. The bike was secured to the rack with a heavy duty chain which was also stolen Incident ref 351-s-280717

<u>Cusop</u> Sometime between Saturday 22^{nd} and Saturday 29^{th} July, thieves gained entry to an unlocked summerhouse in the garden of a residential property and stole three horse saddles from within, one of which was a Stubben valued at £3000 Incident ref 317-s-290717

<u>Kingstone</u> An old mountain bike (make unknown) was stolen from the rear garden of a property in Lowfield Meadow sometime between Thursday 20th & Sunday 23rd July <u>Incident ref 629-s-230717</u>

Arrests of note

A 48yr old male from Kingstone was arrested on suspicion of criminal damage and later cautioned.

A 28yr old male was arrested in **Vowchurch** for an assault, but was later released without charge.

A 55yr old male from **The Golden Valley** was arrested on suspicion of assault and later released on police bail.

A 51yr old male from **Madley** was arrested for causing a breach of the peace, and was charged with assault on police and resisting arrest. He was held in custody for court the next day.

A 24 year old male from **Pontrilas** was arrested on the B4348 at **Kingstone** on Sunday 9th July for driving under the influence of alcohol - he was three times over the limit and was driving a tractor pulling a trailer! The male ran off when police attempted to stop him but was soon caught. He was later charged with obstructing a police officer, driving a motor vehicle with no insurance, driving a motor vehicle without a licence as well as driving a motor vehicle whilst exceeding the prescribed limit of alcohol.

At Hereford Magistrates Court the following sentence was given - disqualified from driving for 50 months (this can be reduced by 12 months on completion of a driving course)

12 months Community Order, £300 fine and £135 costs. He also has to attend a 4 month alcohol treatment programme.

Scams - and how to avoid becoming a victim

A reader from Madley got in touch with details of a scam e-mail he received recently.....

I received an email ostensibly from British Airways saying I could fly anywhere in the world for free if I signed-up as a Mystery Flier and gave an assessment of the service received on the flight.



Quite professionally designed with impressive banners etc . . .

It's offering something for free and a lot of people jump at that without thinking.

Ten Golden Rules to beat the scammers

Be suspicious of all 'Too good to be true' offers and deals, there are no guaranteed get-rich- quick schemes
Do not agree to offers or deals immediately. Insist on time to obtain independent/legal advice before making a decision

3. Do not hand over money or sign anything until you have checked the credentials of the company or individual

4. Never send money to anyone you do not know or trust, whether in the UK or abroad, or use methods of payment that you are not comfortable with

5. Never give banking or personal details to anyone you do not know or trust. This information is valuable so make sure you protect it

6. Always log onto a website directly rather than clicking on links provided by in an email

7. Do not rely solely on glowing testimonials; find solid independent evidence of a company's success

8. Always get independent/legal advice if an offer involves money, time or commitment

9. If you spot a scam or have been scammed, report it and get help

10. Do not be embarrassed to report a scam. Because the scammers are cunning and clever there is no shame in being deceived. By reporting you will make it more difficult for them to deceive others.

Good morning There are a couple of incidents to bring to your attention.

At about 8pm on Wednesday (23rd) two teenage girls were approached by a male walking a three legged whippet type dog on the road between the village and Lower Eaton.

He asked them where they were going, and if he could go with them, he then followed them back into the village; both girls were very shaken up and upset by this as you can imagine.

A blue Ford transit mini bus MY07JMC was stolen from a field in **Abbeydore** (Incident 254-s-300817) **Drones** We have recently had several enquiries about the use of Drones, the information below is taken from the 'Ask the Police' website.

What are drones and are they legal? Drones or Unmanned Aerial Vehicles (UAVs) are essentially flying robots. The aircraft can be remotely controlled or can fly autonomously using inbuilt software controlled flight plans. Designed for designated purposes by the military, they are becoming increasingly popular among members of the public. If you are considering using a drone for recreational purposes, we would advise that you consider the guidance below:

You must not fly the drone above 400 feet in altitude or further than 500 metres away from you horizontally. If you wish to fly one that exceeds the limits above, you will need to seek permission from the Civil Aviation Authority.

Avoid flying it within 150 metres of a congested area or 50 metres of a person or vehicle.

Use your common sense and fly safely - making sure you can see the drone at all times.

If you are using one with a camera, **make sure you inform people** before you start recording and be aware of your surroundings.

Misuse of a drone can lead to a criminal offence being committed. For any further help on how to use a drone safely and legally, please see the websites below.
