Herefordshire record low burglary crime figures Herefordshire police have been working hard to reduce the volume of burglaries across the county.

Our dedicated officers have been making in-roads into reducing the number of burglaries by targeting prolific offenders and proactive operations to clamp down on the crime.

This problem solving approach has produced a reduction, over the past six months, in the amount of homes involved in burglaries by 20% from 132 to 106.

Detective Inspector Ross Jones said: "Being broken into is absolutely devastating and can have a long lasting impact on victims, when someone has unfortunately been a victim we make sure this is followed up with advice and support.

"As well as investigating the crimes that take place and supporting victims our dedicated officers have been targeting prolific offenders and implementing proactive operations with the aim of disrupting these individuals from committing further crime.

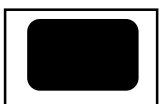
"Our officers, in particular the safer neighbourhood team, use local events, routine patrol and social media accounts to communicate messages to members of the public on how they can help beat the burglar.

He continued: "All these components mean we continue to crack down on burglars and reduce homes being targeted across Herefordshire."

Crime prevention can help play a crucial part in preventing the burglars in the first instance, we want to remind homeowners of the simple steps they can take, making a home unattractive to potential thieves can often make a real difference.

- Install CCTV, burglar alarms and outside lighting;
- Lock front and back doors, even if you are in the house and particularly overnight;
- Keep ground floor windows shut when you leave the house and overnight;
- Hide items such as mobile phones, car keys, wallets and purses, out of view from windows and doors;
- Put lamps and/or radios on a timer to make it appear that someone is home;
- If you are away ask a neighbour to keep an eye on your home, you could even ask them to occasionally park their car on your drive to make it look as though people are currently in.

We Don't Buy Crime is West Mercia Police's response to tackling serious acquisitive crime, which includes crimes such as burglary and theft. The initiative, supported by West Mercia Police and

Drivers Targeted With Fake Fines Information sent on behalf of Action Fraud

What you need to know

Action Fraud have received an increase in reports and intelligence where elderly victims are being targeted by individuals purporting to be police officers or traffic wardens. The victims are being approached whilst parked in a car park and are told by the suspect that they have parked illegally or broken a speed limit and a photo has been taken of their car for 'evidence'.

Victims are advised that they will face a substantial penalty fine unless they pay a smaller upfront fee immediately. Victims, who opt for paying the smaller penalty, will be directed to a parking meter and asked to enter their card and PIN. These parking meters have been tampered with by the suspect in order to retain the card.

Once the victim inserts their card and are asked for their PIN, the victims are shoulder surfed for their PIN by the suspect. Once victims input their PIN, the card is retained by the machine and victims are told by the suspect to seek help from the company who operates the parking meter or their bank.

What you need to do

- If you are suspicious about the authenticity of the fine, do not pay it until you have verified it with your local council.
- Always shield your PIN from view when using an ATM machine, and never share your PIN with anyone.
- If your bank card is retained by an ATM machine, contact your bank immediately to inform them.

Crime Trends 1st - 31st July 2019

Damage was caused to a kitchen window at a property in Syers Croft, **Madley** by an unknown object being thrown sometime overnight on Sunday 7th / Monday 8th July Incident ref 354-s-080719

Overnight on Wednesday 10th / Thursday 11th July a lock up on a farm in **Madley** was broken into and a quantity of tools were stolen, including a generator, a welder and drills Incident ref 519-s-110719

Two males with dogs were disturbed trespassing in a field on a farm in **Bacton** at around 11.10pm on Saturday 13th July. The males, described as aged about 30 and having Birmingham accents, claimed they were lost when challenged by the farmer. They had a Subaru nearby with both front and rear number plates covered, and with several tools in the back. The farmer believes the males were about to catch and kill some of their sheep - there has been a spate of sheep being butchered in their fields in the Midlands area recently Incident ref 857-s-160719

A stable block in **Clifford** was entered sometime during the night of Wednesday 17th / Thursday 18th July, but nothing appears to have been stolen Incident ref 110-s-180719

Two males aged 20 were found trespassing in the grounds of **Longtown** Outdoor Education Centre and using their equipment, on Monday 22nd July. The males were in possession of air rifles which caused added concern for the centre manager. Fortunately there were no young people using the site at the time, and the males when challenged, gave their details and we were subsequently able to speak to them and give words of advice Incident ref 551-s-220719

Lead was taken from the roof of a property in Lower Eaton, **Eaton Bishop** overnight on Wednesday 24th / Thursday 25th July. A shed at the property was also broken into and a trimmer stolen. A trailer that had been hitched to the back of a vehicle had been unhinged and moved but was left with the tail gate down as if the offenders had been disturbed Incident ref 84-s-250719

Burglary offences are continuing to fall in West Mercia, following a committed approach from the West Mercia Police and Crime Commissioner and the police force. Burglaries of dwellings have fallen 6%, and of non-dwellings have fallen 7%*, ahead of the national trend of a 3% decrease.



The Commissioner has invested in a number of initiatives to protect homes and businesses from burglary including Smartwater technology, We Don't Buy Crime Officers and other increased resources around business and rural crime. He's also invested in police resources, including increasing officer numbers and improved victim services, to provide the best possible service to those who are affected.

Other crime types including vehicle crime, bicycle theft, criminal damage and drug offences have also shown a continual decrease, in the most recent figures.

Commissioner John Campion said "I made a commitment to make our communities safer, and this is just one example of how this is being achieved. The investments I have made are not only ensuring the police are better equipped to prevent and deal with crime, but enable the public to protect themselves longer term. My SmartWater offer still stands to those who want to take practical steps to continue to keep their communities safe.

There are of course always areas we can improve on, and I committed to ensuring we continue to work together, to deliver the very best for communities across Herefordshire, Worcestershire, Shropshire, Telford and Wrekin."

West Mercia Police Deputy Chief Constable Amanda Blakeman said: "It is encouraging to see reductions in burglary, however that does not mean we are complacent and our efforts to reduce this even further continue. We know the huge impact being a victim of burglary can have on our communities and are grateful for the opportunity to work with John Campion to strengthen our response and help ensure we're doing the very best for our communities." News from your local Fire Crews

Cold Water Shock Even in sunshine, cold water shock kills.

Now that summer is here, Hereford & Worcester Fire and Rescue Service (HWFRS) is warning people about the risks of 'cold water shock' from jumping or falling into open water.

In the last 10 years, 38 people drowned in Herefordshire and Worcestershire. Of these, 33 were men aged 17+, and five were women. In addition, an 18 year old man died earlier this month after swimming in a quarry lake near Stourport.

On a hot day, rivers and lakes can look inviting, but the water can be extremely cold just under the surface and cause heart attacks even in relatively young and healthy people. Any water below 15 degrees centigrade can seriously affect breathing and movement, so the risk is still great despite the sunshine.

"We also ask people to take care at night after visiting the river and canal side pubs and bars – organise a lift home, or walk with a friend, but don't walk home alone near open water.

"Be water aware - enjoy being around the rivers, canals, and lakes, but don't end up in them on a day or a night out."

Barbecues don't cause too many fires; but that may be due to a history of excellent message promotion by fire and rescue services!

However, it can also be a way in to talk about cooking fire safety more generally.

Barbecue messages include:

- Enjoy yourself, but don't drink too much alcohol if you are in charge of the barbecue or any cooking!
- Make sure your barbecue is well away from sheds, fences, trees, shrubs or garden waste.
- Never leave a barbecue or any cooking unattended.
- Never use a barbecue indoors.
- Keep a bucket of water, sand or a garden hose nearby for emergencies.
- Follow the safety instructions provided with disposable barbecues.
- Never use petrol or paraffin to start or revive your barbecue; use only recognised lighters or starter fuels on coal.
- Empty ashes onto bare garden soil, not into dustbins or wheelie bins. If they're hot, they can melt the plastic and start a fire.



Carbon monoxide There have been incidents of people bringing barbecues into enclosed spaces resulting in carbon monoxide poisoning.
