Response to planning application No P212280/F Farm House Farm, The Barn

There is no mention of the Abbeydore and Bacton, Ewyas Harold and Kentchurch NDP in the application paperwork and it would therefore appear that the applicant has not tested the application against this current, made, plan.

We object on the basis that the proposal has not been tested against the ABEHK NDP.

Specifically, we have concerns over the following policies.

Policy G6 – Highways and Transport

This policy states:

All new development proposals should include appropriate measures to minimise their impact on the Neighbourhood Development Plan Area by providing:

- a. Safe and suitable access;
- b. Any necessary and appropriate traffic management measures;
- c. Off-road car parking that avoids the use of large areas of hard standings, particularly using materials more appropriate to urban locations. All car parking should be appropriately sited and screened within the landscape; and
- d. Access to public transport including the creation of permissive footpaths to bus stops, where appropriate. The access to the public highway is a partially blind turning and consideration needs to be given to whether it is safe and suitable access. In our estimation the access needs to be modified to make it safe for both visitors to the site and traffic on the highway.

There is another issue of concern with the access. The driveway is owned by a number of parties with various rights of access for domestic use. We ask whether there is an issue with change of use from domestic to commercial.

Policy G7 – Rural Environment and Tranquillity.

This policy states:

To protect the integrity of the rural environment and the tranquillity of the Golden Valley development proposals will only be supported when they do not give rise to significant adverse impacts on these resources. The following criteria will be used to assess proposals

to help determine their appropriateness:

- a. The use, nature, scale, type of activity and opening hours (where appropriate) of any proposal.
- b. For business and tourism proposals a Noise Impact Assessment may be required with any planning application, and may be required, in certain circumstances, for other forms of development; and
- c. The inclusion of mitigation measures to avoid, reduce or remedy any adverse impacts arising from the proposed development. Such measures will be conditioned where necessary.

The planned operating period is from March to May and the treeline between the proposed site and the adjacent property, Farmhouse Farm, is clearly deciduous. This means that it is not going to be effective as a screen until the end of the operating period, trees do not normally have much leaf growth until May. We note that the applicant is prepared to plan more trees or install suitable screening but consideration needs to be given to the type and they should, perhaps, plant an evergreen or beech hedge that retains screening all year round.

This is relevant to the issue of noise, as bare trees are far less effective at stopping noise than those in leaf. The site is very close to the adjacent property and while the applicant has said it will be an alcohol-free site, this does not remove the issue of noise. We would suggest that a Noise Impact Assessment would be appropriate due to the proximity of the site to the adjacent property.

Policy G8 - Dark Skies

This policy states:

To minimise light pollution in the Golden Valley and to improve the views of our night time skies, planning proposals that include external lighting and significant openings that would allow internal lighting to be seen externally, will have to demonstrate the following:

- a) They have undertaken an appropriate assessment and can demonstrate the need for the lighting proposed;
- b) That care has been taken to provide appropriate lighting, using systems designed to prevent obtrusive lighting nuisance, minimise light pollution and reduce energy consumption.

The applicants have not discussed any plans for external lighting but it is clear that the huts will be lit. There may be safety requirements for external lighting on the path to the huts and there may be external lights fitted to the huts to light the porches. It will still be getting dark early evening for some of the operating period.

We would suggest that information be requested about external lighting and also whether lighting is going to be required for health and safety reasons. If so then the lighting needs t comply with this policy."

Missing Post Box at Bacton update

Second letter sent to Royal Mail 8<sup>th</sup> December 2020

"I refer to the Parish Council's enquiry dated the 12<sup>th</sup> October 2020 in respect of a missing Royal Mail Post Box.

The Parish Council considered your reply with some dismay as clearly the writer was unaware of the locality, almost all of the properties in question are outside the catchment area for the other post boxes listed. Prospective users would have to have access to a vehicle as well as the ability to drive to reach these boxes.

In this very rural area the postman does not necessarily call at each property, with many properties having a remote locked letterbox at farms or driveway gates which the postman uses therefore the homeowner will not actually see the delivery person, thus no way of actually handing over a letter for outgoing post, the option to leave something out for the delivery person is clearly not possible as with no guarantee of a delivery to that property the outgoing post would remain uncollected.

All the residents are asking for is the replacement of a post box, removed when the telegraph pole to which it was affixed was damaged by a falling tree.

Your reference to the necessity to consult with the highways authority as well as the various utility companies is quite absurd and confirms the lack of any local knowledge as the replacement box would be clamped to the telegraph pole as before.

On behalf of the residents, the Parish Council request that you give this your urgent attention.

Thank you for your communication dated 28 June regarding the removal of a postbox in Bacton, Hereford in your Hereford and South Herefordshire constituency.

I have now received an update from the collections team for the area who confirm that the postbox in Bacton was removed as the telegraph pole it was attached to had been damaged. Our regulator, Ofcom, requires Royal Mail to ensure that 98 per cent of all households across the UK should be within half a mile of a postbox. For the remaining two per cent, Royal Mail must provide sufficient postboxes or other means of access to the Universal Service (e.g. collection on delivery) to meet the reasonable needs of users, having regard to the costs and operational practicalities of doing so. Royal Mail currently meets this condition at c.98.3 per cent.

I am advised that postmen and women delivering to addresses in Bacton are more than happy to collect mail bearing the appropriate postage directly from residents. This option is always available and is especially good for any residents finding it difficult to access a postbox. The postmen and women are not permitted to take cash to buy stamps or to take items to the Post Office.

I am sorry to send you what I know will be a disappointing reply. As always if I can be of any further assistance please do not hesitate to contact me.
