You will see the letters in April & June 2022 were directed to the Escalated Customer Resolution Team neither of which have been replied to.

I urge you to read the series of communications attached which outline the need to replace this very rural mailbox which was only removed because of the telegraph pole on which it was mounted being damaged by a falling tree. Clearly the pole has long since been replaced.

The replacement of the mailbox will avoid the need for the postmen/postwomen having to call to collect mail from the rural properties as has been suggested previously in the various replies.

Can you please resolve this ludicrous situation by having the mailbox replaced?
