#### 8.0 **Grant Application**

Dore Abbey PCC request for a Grant towards a Paupers Grave Project

"23<sup>rd</sup> November 2024 11:57 The Dore Abbey is seeking a grant for the current Paupers Graves Project. We have cleared an overgrown area in the churchyard of brambles, stones and elder. This area is known as the Paupers Graves which was used to bury the dead from Abbeydore workhouse between 1838 and 1920.

We visited Hereford Archive centre and discovered 210 souls were buried in this area.

We now have the names, age and the date they died. They were possibly buried in shrouds with little ceremony.

The plan is to install and engraved headstone which we have sourced from a local quarry.

An information board that will cover the history of Abbeydore Workhouse and the type of lives the inmates endured.

A memorial bench and also a cider apple tree as the inmates drank cider on occasions. A book will be provided for visitors to the Abbey listing the names etc. of those buried there.

We have now obtained the cost of the required items and the total cost is £4,000 pounds.

Would the Parish Council consider funding this project. We have decided to approach your selves as this project will be of local interest and relates to previous residents of the area.

#### 9.0 **Grant Application**

Dore Abbey PCC request for a Grant towards installation of a composting toilet at the Abbey "13<sup>th</sup> December 2024 12:42

I am contacting you on behalf of the Dore Abbey PCC.

We are currently seeking funding for a composting toilet at the Abbey as there are currently no toilet facilities available. It is the only suitable option available due to the restrictions placed on us by Historic England.

This will be used by the general public and local parishioners. We currently use port-a loos for events and as you can imagine this is far from satisfactory and costly. The footpath is part of the Golden Valley Pilgrimage route and next year we plan for pilgrims to sleep over in the Abbey

We have undertaken a great deal of research including visiting other churches with composting toilets supplied by Nat Soil. We have identified an area by the South Lytch gate where it could be installed. We are looking at the Nat Soil system and the total cost will be in the region of 16k. It will be suitable for disabled use. Needless to say any sum the Parish council could contribute to the scheme would be appreciated.

Please would you be good enough to include it as an agenda item on the 7th January.

Please can you also confirm if it ok for me to present details of this project along with The Abbeydore Workhouse project.

# 10.0 Highways and Footpaths Issues

10.1 To receive new information on Parish Highways & Public Footpaths

**10.1a** Issues related to recent flooding on the B4347 outside Dore Abbey & The Old Rectory

"28th November 2024 09:32 Subject: Flooding in Abbeydore

Dear Matthew and Barry,

The last months' rains have prompted me to write to you regarding a longstanding and worsening problem affecting Abbeydore and Dore Abbey.

As I am sure you know, Dore Abbey is a building of considerable historic importance, reflected in its listing, as well as a community space and place of worship. Over recent years the state of the roads and in particular the effectiveness of the drains has deteriorated significantly, such that during periods of heavy rain rivers of water cascade along the boundary road eroding the road surface. In addition, the drainage to the north of the road by the lych gate has disappeared and those to the south of the lych gate are unable to cope. It is not unusual to see significant water in the lych gate and rivers running down the path into the Abbey grounds and graves. Thankfully it has not yet reached the Abbey itself. This cannot be good for the road surface nor the structure of the lych gate, the footpath, listed boundary wall, the Abbey's schedule ancient monument grounds nor the relics found under the ground.

I would ask that all concerned review the drainage on the road passed the Abbey with a view to taking mitigating steps to reduce rainwater run-off and flooding.

Terry (The Parish Council's Lengthsman Contractor) has previously camera and water tested the system, the conclusion being that the drainage system just does not have sufficient capacity to take the volume of storm water

**10.1b** Issues related to flooding and road condition on the C1225 in the Jury Bridge / Farm area "Linda Brown 20<sup>th</sup> December 2024 12:48 Subject: Flooding of road at Jury Bridge

Good afternoon, I am hoping that you are able to help with a problem with flooding in the area of Jury Bridge, in the area of Lower Jury Farm, Bungalow, Cottages, etc.

The road has been subject to frequent flooding over the last year or so, to the point that it is impassable at times of moderate to heavy rainfall. As many other local roads also flood for a variety of reasons it restricts travel very badly.

A lot of work has already been done further up the road towards the Kingstone/Wormbridge/Abbeydore junction which has proved extremely effective. However, this water is now gathering in an area which is not effectively drained so creating more flooding.

The main problem seems to be that the level of the ditch on the left of the road, towards Forty Acres, is higher than the level of the road so the three drainage ditches dug along the middle of the bank allow the water to come back onto the road. The first drainage point by Jury Brook Cottage was effective - until all the spoil from the last work there was put in the ditch by the drainage point!!

The drainage points on the right side of the road also need to be cleared so water can leave the road.

The situation is compounded by hedge cuttings and erosion of ditches by the hedge cutters undertaking this work and obviously, by the large size of tractors using the roads.

I have tried to clear some obvious problems areas but frankly, this is beyond my abilities! I am more than happy to meet on site to clarify."
